MEETING MINUTES

8 AM; 9/17/021; BSCWSD Board Room

I. Regular Board Meeting Public Forum and First Board Meeting Logistics

II. New Business

A. Funding updates (ARPA Applications, SRF Priority List, lobbying efforts) – Discuss Mace Mangold of WGM Group presented update: The GCCWSD sewer project was ranked 61 of 241 competitive APRA grant applications and will be awarded \$2million. This is the maximum award with the updated ARPA funding structure. (When the application was submitted there was a \$25 million per project max. The funding was restructured to award up to \$2 million for the 73 highest ranked projects. The board should receive an award letter soon with more details. Additional funding sources will be needed, and the funding strategy laid out in the PER and ARPA application will need to be updated. It will probably be best to fund and create the proposed project in phases. There will be at least one more round of competitive ARPA funding. The structure and timeline of this is unknown currently. GCCWSD would apply through Gallatin County for ARPA minimum allocation funds once a process is established. A funding summary is attached.

BSWSD WRRF Phase 1, which is required for the proposed GCCWSD project, was ranked 39/24 and will also be awarded \$2 million dollars.

An excerpt of the ARPA project ranking list and letters of support received so far were provided to board members (see attached).

<u>Group Discussion</u>: Possibility of challenging the new \$2million allocation doesn't seem realistic. There is a perception of "Big Sky doesn't need more money" and this will affect

funding. For future lobbying, the board has been advised to break funding asks into categories focused on environmental issues. There may be benefits to breaking the planning and site assessment work into smaller projects to maximize funding. Breaking the actual sewer design and construction into phases will also help funding.

Projects around Montana may struggle to spend ARPA money on time – both Big Sky projects are in a good spot to be able to proceed.

Next steps of ARPA are unknown but the District should be following this closely.

B. Next Steps – Discuss – Mace Mangold of WGM Group presented update: Engineers have a draft discharge report for permitting but are waiting on more detailed data from the current MBMG (Montana Bureau of Mines and Geology) groundwater study in the Canyon.

There may be a few wells that would be in the path of proposed wastewater discharge – it needs to be evaluated whether the project would affect public health through drinking water. It could be positive, negative, or neutral. Eventually, a public water system will likely be the best option for this community. There are water rights constraints, but possible ways to mitigate. Prioritize sub-projects and funding asks for future funding asks.

Some canyon sewer planning prioritization was done with the Resort Tax Board and BSCWSD before the GCCWSD was created which can be translated into a phasing plan. The District should try to capture the red flag areas (from a health and environment perspective) in earlier phases. Engineering updates will be needed.

Group Discussion: The District will need to prioritize phasing and sub-projects.

Getting interest to join the District is an important next step. There are community members who have failing or soon-to-fail sceptics that are asking board members when the sewer will be coming. There tends to be interest in adding extra units on the property once the sewer is there and provides the opportunity. The board hasn't heard concern about costs yet. This is promising for the district expansion which will be needed to make a cost-effective system that meaningfully addresses health and environmental concerns.

There is an opportunity for have 4:30-9 booth at the community meeting run by the Big Sky CommUNITY Forum Oct 26th. WGM Group will man the booth to tell the District's story, gauge interest in joining, and ask permission to inspect existing septic conditions. WGM Group was tasked with making a survey that can be distributed at this and on the District's website once it is operational. This could be used to keep interested parties informed and also help prioritize connection/annexation/construction phasing planning.

There is also an upcoming joint Gallatin and Madison County commission meeting – GCCWSD should be a presence.

The ground water study is currently scoped as a desktop assessment of potential discharge sites. This will need review by DEQ and then can be advanced to field verification and actual discharge permit submittal. These next steps have not been contracted.

BSCWSD is expecting 2x disposal for 1x canyon treatment. A formal agreement is still needed.

Development will be limited by water rights.

The board requested price estimates and scope proposals for next steps of the Disposal permitting effort and for water rights services.

Get a Big Sky ARPA call should be planned. Engineers or Tax board can lead this.

The Gallatin County Minimum Allocation pot of ARPA funding is promising. Can highlight the strong environmental, economic development and workforce housing benefits.

GCCWSD SEWER PROJECT FUNDING UPDATE

9/17/2021 | WGM Group

GCCWSD was ranked 61 out of 241 competitive grant applications and will be awarded \$2 million for the proposed project. This is the maximum award with the updated ARPA funding structure. (When we applied there was a \$25 million per project max. The funding was restructured to award up to \$2 million for the 73 highest ranked projects, for a total of \$121,102,556). An award letter should be arriving soon.

BSWSD WRRF Phase 1, which is required for the proposed GCCWSD project, was ranked 39/24 and will also be awarded \$2 million dollars.

Current GCCWSD Sewer Project Funding Status:

Additional funding sources will be needed, and the funding strategy laid out in the PER and ARPA application will need to be updated. It will probably be best to fund and create the proposed project in phases. CWSRF loans and ARPA grants from Gallatin County's Minimum Allocations and future rounds of competitive grants will likely be major contributors. Other funding options will be explored as well.

There will be at least one more round of competitive ARPA funding. The structure and timeline of this is unknown at this time. Applications for minimum allocation grants are being accepted on an ongoing basis until January 1, 2023 – GCCWSD would apply through Gallatin County. This process is not yet established. The project is on the CWSRF Priority Project List and Intended Use Plan and eligible to apply anytime now.

This ARPA award is contingent on DNRC approval of final scope, schedule, and budget including verification of all matching fund sources. Recipient of this award is responsible for all cost overruns beyond the total of the award and costs of the audit, if not included in the ARPA budget. DNRC requires compliance with Montana Water Use Act Title 85, Chapter 2, MCA.

The Big Sky County Water and Sewer District (BSCWSD) and recently formed Gallatin Canyon Water and Sewer District (GCWSD) are collectively working on two infrastructure project applications for American Rescue Plan Act (ARPA) funding:

- 1. Sewering the Gallatin Canyon and pumping wastewater to the BSCWSD's Water Resource Recovery Facility (WRRF), and
- 2. Expanding and upgrading the BSCWSD's existing WRRF to enable it to accept Gallatin Canyon wastewater along with existing and future development within the District's own boundary while treating the wastewater to Montana DEQ Class A-1 standards to minimize nutrient loading in the Gallatin River watershed.

The infrastructure necessary to sewer the Gallatin Canyon corridor and pump the wastewater to the BSCWSD WRRF will cost an estimated \$25 to \$35M to design and construct, but will eventually eliminate septic systems in the corridor, protect the main stem Gallatin River as well groundwater potable wells in the area. Expanding and upgrading the BSCWSD is costing \$41.4M for construction, and an additional approximately \$10M for engineering, financing, and construction administration. Three bid alternates that would be needed with inclusion of Gallatin Canyon wastewater could not be accepted upon bidding, due to BSCWSD ratepayer affordability. Together, if added to the project, these bid alternatives would add another approximately \$8.5M to the project.

Due to the high costs for this infrastructure the Districts are pursuing ARPA grant monies. Together, these projects provide improved protection of our region's environment and drinking water supply, while enabling development of affordable housing for the area's stressed workforce.

There will be two applications aligning with the infrastructure projects described above. The first application, for sewering the Gallatin Canyon and pumping the wastewater to BSCWSD's Big Sky WRRF, will be led by the newly formed Gallatin Canyon Water and Sewer District, and will be for the maximum funding amount of \$25 million.

The second application, for the Big Sky WRRF Phase 1 three bid alternates that were not awardable upon bidding, will be led by BSCWSD for \$8.5 million. The BSCWSD will also ask for an additional \$16.5 million for the WRRF Phase 1 project which is under contract. This will make our request 25 million dollars.

The Commissioners believe that these projects require and benefit the County taxpayers. The County also endorses these projects to be given serious consideration.
